

**Arbor Dog Park Action Committee, Inc.  
Board of Directors Minutes  
February 9, 2009**

1. Barb Metheny called the meeting to order. The guests were welcomed and all attendees introduced themselves.
2. Jon Hagey gave the treasurers report. The current balance in the ADPAC account is approximately \$7,600.
3. Barbra summarized the issues pertaining to whether ADPAC should continue as a 501(c) (3) charitable organization. **(See Secretary's Note Below)**. She also explained that if ADPAC were dissolved, the money would be turned over to the city to be earmarked for the benefit of Arbor Dog Park. Fundraising activities could still continue. Board members will be elected at the April 4<sup>th</sup> annual meeting. Joan Laszlo is the only present board member who would be transitioning to the new board.
